### Leather Trim Interior

We warrant the Authorized Leather Program products installed in Enterprise Car Sales vehicles for sixty (60) months or sixty thousand (60,000) miles from the date of original retail delivery or original use, whichever occurs first. During this term, Roadwire Leather Interiors shall replace or repair any Authorized Leather Program product installed on an Enterprise Car Sales vehicle which proves to be defective in material or workmanship.

The buyer shall not be entitled to recover from the manufacturer, or an authorized Enterprise Car Sales dealership, any consequential damage, loss or expense for loss of use, loss of time, loss of profits or income, or any other incidental damages arising directly, or indirectly from a warranty claim of this product.

Warranty does not cover claims for scuffs, scratches, tears, abuse, or excessive wear. Silicone based products or harsh chemicals may harm the surface of your leather interior. Use of these products will void the warranty.

Obligations of this warranty shall be to repair any defective merchandise that is returned, or at the option of the manufacturer, to replace it with similar merchandise. Roadwire Leather Interiors will not be held responsible for variations in color dye lots, in connection with any warranty claims. Roadwire Leather Interiors reserves the right to change, modify, or discontinue products without any obligation in regards to products previously manufactured.
